Availability

Laranjazaal

All year round between 09:00 and 01:00. For every reservation of two hours or more a day part will be charged. For earlier starts or extensions of one hour or more, an hourly rate + one hour of staff costs will be charged.

Oranjerie

All year round between 18:00 and 01:00.

Palmenkas (left wing)

The Palm Greenhouse is available from May 15th until October 1st *only* and can be rented between 16:00 and 22:00. The main hall and outside area of the Palm Greenhouse are only available for standing occasions from 17:00 onwards. Preparation for any event in the Palm Greenhouse may, where it concerns the east wing (otherwise known as the Indian Greenhouse), not commence any earlier than 15:00. Setting up in any other part of the Palm Greenhouse may not commence any earlier than 17:00

Catering

Small parties and snacks can be catered by the Hortus.

It is possible to have an external caterer cater in the Museum Café for a buy-out fee. This caterer is obliged to visit our location no later than 3 weeks prior to the event to receive our conditions and view our facilities.

Music and sound

Our exploitation permit contains some noise restrictions. To comply with these rules and to maintain a good relationship between the Hortus and its neighbours, we have strict sound regulations. We ask for your understanding in this matter.

The volume produced during your event is subject to the judgement of our staff at all times.

There is a modest sound system in the Laranjazaal. This is the only sound system allowed in the Laranjazaal.

In the Palmenkas music cannot exceed the level of background music. A modest and mobile sound system is available for the Greenhouse.

In the Oranjerie amplified music may only be played through our music installation or by one of our DJs.

Maximum volume in the Oranjerie is 80 dB at all times.

When sound levels approach this limit, all doors to the terrace must be closed.

After 22:00h all doors must be closed. You are still allowed to go outside of course.

Acoustic live music is only allowed indoors.

Drinks

The Hortus provides the drinks for your event. The only exception possible is with regards to the wine. It is allowed to bring your own wine or champagne. For this we charge a corkage fee per bottle.

Staff

If the Hortus does not cater your event, the Hortus will not provide the staff necessary for the catering. The hiring, build up, dismantling, preparation and serving of all related consumptions are the responsibility of your selected caterer.

The Hortus staff is responsible for the rest of your event as well as for managing the venue. When deemed necessary, our staff is permitted to correct or remove you or your guests from the location at all times.

The Hortus exhibition contains many rare and valuable flora. For this reason an usher, which will be provided by the Hortus, is mandatory.

Materials and decorations

The Hortus has a limited range of supplies for the decoration and set up of your event. In most cases, the decoration of your event is your caterers or planners responsibility. The caterer or planner has to rent the desired supplies through rental company Servé.

Any decorations or other supplies must first be approved by the Hortus, due to the fact that our venue has many National Monuments and our collection contains fragile and rare flora. Please note that nothing may be attached to the buildings or the plants in our collection, nor is it allowed to move the plants in our collection.

Any materials you or one of your guests bring to the Hortus have to be taken away after your event. The Hortus cannot be held responsible for these materials at any time or in any situation.

Open fire on the terrace is only allowed when there are no potted plants in the surroundings. This is approximately between October and April. Open fire is not allowed anywhere else.

The use of drones is forbidden in the Hortus.
